Fifteen years is an achievement we want to celebrate all year long. Our organization is vibrant and evolving to meet the professional and personal needs of its members. One thing that hasn't changed is our mission to be a resource to help expand our sphere of influence and to have a positive impact on our community. The Board and the Executive Committee each meet every quarter to discuss the "how" of our mission – how to create opportunities for positive impact.

ICWW leadership wants to further our mission in meaningful ways through our expanding network of talented members and events. There has been an ongoing dialogue at the Board and EC levels regarding the organization's financial strength and sustainability. It's been a "spirited" discussion about ICWW's financial options and the future - the role of event sponsorship, membership dues and how, if at all, we should invest funds that have historically been reserved for a rainy day. Out of this dialogue some important decisions have been made by the Board and I would like to share them with you.

- Increase membership annual dues for resident and non-resident members for the first time since ICWW's beginnings in 2003. Resident dues will be \$500 and Non-resident dues will be \$125.
- To Authorize ICWW's Treasurer to open an investment account and to invest a portion of ICWW funds.
- An ICWW 2019 retreat will be organized by 3 retreat co-chairs: Julia Sabin, Elaine Price and Kate Hubben.
- Starting in 2018, Board and Executive Committee Meeting Agendas and Minutes will be posted on the ICWW website www.incounselwithwomen.org. To access, go to the "Member Login" tab, and once you put in your password, you will see a tab along the top for "*Members & Committees*". Click on it to see meeting dates and meeting agendas and minutes.

These changes will help to facilitate our events in the face of declining sponsorship dollars, and also reflect findings of the recent membership survey. Ultimately, the Board believes the result of its recent decisions will provide transparency as well as sustainable financial footing for the next 15 years of ICWW leadership and beyond.
